## FAIR-SHARE INVESTMENT SCHEDULE

The Investment Schedule is a guideline for determining an appropriate investment amount for new and current members.

1 - 10 employees.....\$325  
11 - 20 employees.....\$375  
21 - 50 employees.....\$425  
51 - 100 employees.....\$500  
100+ employees.....\$1000

A one-time administrative fee of \$25 will be assessed for each new membership.

## BUSINESS CLASSIFICATION EXCEPTIONS

Each business classification listed below pays the minimum business investment of \$325, plus what is listed by each classification. A one-time administrative fee of \$25 will be assessed for each new membership.

- Home Builder: \$6 per home
- Insurance: Each agent invests individually
- Investments: \$30 per each additional broker
- Real Estate: Each agent invests individually
- Apartments: \$1 per unit
- Hotels/Motels: \$2.50 per room
- Accountant/Legal/Medical: \$60 per professional
- Banks/Credit Unions: \$50 per million in deposits
- Developers: \$1750 (Large) \$1150 (Medium) \$600 (Small)
- Individual: \$275 (no business affiliation)
- Nonprofit Organizations: \$275
